### T. ROWE PRICE GROUP REPORTS PRELIMINARY MONTH-END

### ASSETS UNDER MANAGEMENT FOR NOVEMBER 2021

BALTIMORE (December 10, 2021) - T. Rowe Price Group, Inc. (NASDAQ-GS: TROW) today reported preliminary month-end assets under management of \$1.63 trillion as of November 30, 2021. Client transfers from mutual funds to other portfolios, including trusts and separate accounts, were \$1.1 billion in November 2021, and \$4.2 billion for the quarter-to-date period ended November 30, 2021. This brings total client transfers for the year-to-date period ended November 30, 2021, to \$22.6 billion. These client transfers include \$0.7 billion, \$2.9 billion, and \$15.6 billion, respectively, transferred to the target-date retirement trusts during the November, quarter-to-date, and year-to-date periods.

The following table shows the firm's assets under management as of November 30, 2021, and for the prior month-, quarter-, and year-end, by investment vehicle, asset class, and in the firm's target date retirement portfolios.
